The emotional, cultural and social well-being of people is a significant factor in their recovery


People affected by Stroke and their Family/Carers



VOLUNTEERS

In 2017/18, our volunteer hours accumulated to **7,284 hours** over the year. If the volunteer's hours were costed out at \$25 per hour this would represent a saving of **\$182,100.00** to government in service provision costs.



PRESIDENT'S REPORT

2017/2018, what a great year for the Association. With the finalisation of our '40 and Fabulous' celebrations. we also ended the financial year with renewed confidence in the ability of the Association to sustain its' work in the long term.

I congratulate the executive management, the staff and our wonderful volunteers for their initiative and ongoing commitment to driving the Association forward, continuing to work diligently with finite resources to provide excellent services to clients and members of the Association.

In the latter part of the 2017/2018 financial year, we moved from an organisation concerned about our ability to sustain the programmes of the organisation due to impending funding cuts, to one that is in a very sound financial position, to not only sustain programmes but to grow and develop programmes in the 2018/2019 period.

This was only achieved by the strength of our members particularly from our Stroke Recovery Clubs who lobbied government both at a Local and State level to ensure our Advocacy funding was sustained for at least the next financial year. This was combined with the success of staff in obtaining a substantial Grant under the NDIS Information Linkages and Capacity Building Programme means we have a very bright outlook in to the future.

Performance Review

The performance of the Association continues to be a source of pride for all of those involved. It is recognised that as a small organisation, we punch above our weight with what has and will continue to be achieved.

The Associations' statistics indicate that the services and programmes are continuing to perform well.

Strategic Plan

The Board continues to monitor and oversee the work of the organisation with the development of an Annual Strategic Plan. This provides the staff with a blueprint of the expected organisations strategies and outcomes to be achieved in each calendar year. The plan is evaluated in November/December, enabling us to refresh and refine the organisational programmes as required.

Advocacy

The CEO continues to be very active in advocating for services through all levels of Government. This is a vital aspect of the Associations' mandate and this is expected to increase with the support of the new staff. We will continue to be involved with NSW Health and Transport NSW with the provision of consumer representatives. It is vital that we have a seat at the table and ensure that the voice of Stroke survivors continues to be heard in the provision and planning of services in NSW.

The Associations' utilisation of Social Media is becoming an ever increasing platform in our Advocacy projects.

Support and Information

This aspect of the Association's work continues to grow. The increasing need for support after Stroke, the changes made by the introduction of NDIS and the changes to the aged care system, have highlighted the ongoing need for our support line.

Support of Stroke Recovery Clubs

We have held two regional telephone conferences involving Stroke Clubs during 2017/2018, which is designed to increase interaction in and between clubs in each region.

These teleconferences will continue to be held twice a year. The second scheduled teleconference in 2017 was supplemented by a combined Club Picnic in each rural area of NSW.

The combined Club events continue to become more popular with additional events held last year to celebrate the final half of our "40 and Fabulous" celebrations. The 2018 Stroke Clubs Survey has been completed and the results distributed to Clubs.

These results will be used to inform the Stroke Clubs Coordinators in their role to support existing and develop new Stroke Clubs over the next twelve months.

The Board has identified priority areas as Macarthur, Nepean, Wagga Wagga, Dubbo, Richmond Valley and a virtual /online Club.

Stroke Awareness and Education

This continues to be the major focus of our year. The ongoing support of our Patron His Excellency David Hurley AC DSC Governor of NSW, will ensure that it continues to grow.

The events "Creating Connections " and the Stroke Choirs Recital Day are now well established in the organisations calendar.

Accreditation

The Association was successful in completing a Third Party Verification process. This is an outside review of the Associations Policies and Procedures undertaken by QIP.

The Association passed the review with no changes required to our policies and procedure in April 2018.

Moving Forward

As we move into 2018 we can look back on the past twelve months with enormous pride in the achievements of this Association. It is anticipated that with the appointment of the Clubs Coordinators, we will have the resources to support new and existing Clubs in an enhanced dimension.

In 2018/2019 your staff and Board of Management will remain committed to working with Stroke Survivors and their carers to ensure that the interests and the voice of Stroke Survivors are well represented within NSW and work to expand and diversify our services.

You can be confident that the Board will continue to evolve with the Association, to meet the changing need of our members and the Stroke community.









TREASURER'S REPORT

I would like to begin my report by stating that as a result of a number of factors the Association has completed the 2017/2018 with our Statement of Financial Position indicating that the Association is in its most sound financial position ever.

We have ended the year with an operating profit of \$526,234. The Income and Expenditure report indicates that there has been an increase in monies received from all forms of income. This years profit however, was primarily as a result of several very generous bequests.

Our investments have returned an increased performance in relation to previous years and the Board will continue to work to maximise the benefits of the surplus monies from 2017/2018 using the existing investment strategy.

The financial overview gives you a compact picture of how monies have been received and expended over the past year. We cannot stress enough our gratitude to those who have remembered us in their passing.

The overall annual expenditure in 2017/2018 has decreased. This however will be short term as we intend to utilise accumulated fund to support the development of new services for both our urban and rural members and consumers.

Staff have worked diligently to source alternative sources of funding. We were successful in obtaining a two year funding grant for the development of the Stroke Recovery Clubs. A very positive way to end the last financial year.

This funding through the NDIS- Information, Linkages and Capacity Building Programme, along with the bequests received will ensure the longevity of the Association and its valuable work.

I would like to express our appreciation to Hill Rogers, for their excellent work in relation to our Audit report. We would also like to thank Geoff Stein, our honorary solicitor for his work with the negotiation of our bequests.

Moving Forward

As we move into the 2018/2019 financial year, we are in a very strong and viable financial situation with a total cash reserve of \$1,042,624, an increase of \$620,173 or 147% on last year's position.

We are confident that our present level of funding is secure from NSW Health and NDIS until June 2020. However, we will striving to ensure continued funding from the NSW Government for our Advocacy and Information Programme from July 2019. While this funding was reinstated for the 2018/2019 period this is only on a one year extension.

We will continue to work with Advocacy
Alliance in their ongoing lobbying to have
Advocacy organisations recognised by the
NSW Government and the ongoing funding of
these vital organisations permanently
reinstated.

While the Board is cognisant of the ever increasing need for our services, members should feel assured that financial diligence their primary concern. We will continue to work conscientiously to seek alternative sources of revenue to enable the Association to continue to move forward.


